Ibrahim Elbadawi is the Managing Director of the Economic Research Forum (since January 2017-August 2019; August 2020- present). Minister of Finance and Economic Planning, Republic of Sudan (Sept 2019-July 2020). Professor Emeritus, University of Khartoum. Before that he was Director at the Economic Policy & Research Center, the Dubai Economic Council (2009-2016); Lead Economist at the Development Research Group of the World Bank, which he joined in 1989; and Professor of economics at the University of Gezira in Sudan. He holds a PhD in economics and statistics from North Carolina State and Northwestern universities in the USA. During his work at the World Bank he also served as Research Director of the African Economic Research Consortium (Nairobi, 1993-1998), on external leave from the Bank.

He has edited 13 books and special editions of referred journal and published about 90 articles on macroeconomics, growth and development policy, democratic transitions and the economics of civil wars and post-conflict transitions. His regional specialization covers Africa and the Middle East. He is also a (non-resident) research fellow with the Center for Global Development. Dr. Elbadawi is the editor of (with Hoda Selim) of: Understanding and Avoiding the Oil Curse in Resource-rich Arab Economies (Cambridge University Press, 2016); and, Ibrahim Elbadawi (with Samir Makdisi). Senén Florensa

Senén Florensa is the President of the Delegate Committee and General Director of the European Institute of the Mediterranean (IEMed) with the range of Executive President, Chair of EuroMeSCo General Assembly, and director of the quarterly afkar/ideas and of the IEMed Mediterranean Yearbook.

A diplomat, he holds a degree in Economic Science and in Law from the Universitat de Barcelona. Dr. Mona Said

Mona Said is currently a professor of economics at The American University of Cairo (AUC), Egypt. She earned her BA and MA degrees in economics from AUC and her MPhil and PhD degrees in economics from the University of Cambridge, United Kingdom, where her doctoral research was on the political economy and econometrics of labor market segmentation and institutional change in Egypt.

She previously held the position of Regional Economic Consultant on the South Eastern Mediterranean (SEMED) Region, at the Office of the Chief Economist of the European Bank for Reconstruction and Development (EBRD) London, United Kingdom, and was an Economic Consultant to various International European and Euro-Med Institutions (UN Women, ILO, European Training Federation and FEMISE). She was also previously a lecturer in economics and assistant professor with reference to the Middle East at the Economics Department of the School of Oriental and African Studies (SOAS), London University. She also held operational positions at the Middle East and North Africa Department of the World Bank and Policy Development and Review Department of the International Monetary Fund. Said is currently an academic affiliate of the London Middle East Institute (LMEI), SOAS, London, board member of FEMISE (the Euro-Mediterranean Forum of Institutes of Economic Sciences) France and an active Research Fellow of the Economic Research Forum for Arab Countries, Iran and Turkey.

Her current research interests are in labor and human resource economics, poverty and income distribution, gender gaps in earnings and job quality and equity implications of trade policy, Islamic finance and micro-finance. Her publications have appeared in several international refereed venues such as: Economic Development and Cultural Change, Journal of Developing Areas, Comparative Economic Studies, Review of Radical Political Economics and in books by Oxford University Press and Springer.



H.E. Dr. Rania Al-Mashat

H.E. Dr. Rania A. Al-Mashat is an accomplished economist and public policy leader with over 20 years of international experience spanning central banking, monetary policy, sustainable development, and climate finance. Currently serving as Egypt's Minister of Planning, Economic Development, and International Cooperation, she has held prominent roles including Egypt's Minister of International Cooperation (2019–2024) and the first female Minister of Tourism (2018–2019).

She played a pivotal role in modernizing Egypt's monetary policy during her tenure as Sub-Governor for Monetary Policy at the Central Bank of Egypt (2005–2016) and contributed to global economic reforms while working at the International Monetary Fund. Al-Mashat spearheaded Egypt's NWFE platform, an initiative to mobilize climate finance and advance the green transition, and authored the "Sharm El-Sheikh Guidebook for Just Financing."

Al-Mashat has represented Egypt in numerous international financial institutions and serves on advisory councils and global alliances, including leadership roles at the World Economic Forum. She has received multiple prestigious awards, such as the 2022 Most Visionary and Outstanding Minister of International Cooperation in Africa and the 2019 Global Champion Award for her tourism reform achievements.

An accomplished author, she wrote "Stakeholder Engagement Through Economic Diplomacy" and contributed to key publications on monetary policy and climate finance. She holds a PhD in Economics from the University of Maryland, along with executive education credentials from Harvard and Oxford.



H.E. Amb. Nasser Kamel

H.E. Amb. Nasser Kamel, Currently the Secretary General of the Union for the Mediterrean. A career diplomat for the Egyptian government, Amb. Kamel held the position of Ambassador of Egypt to the United Kingdom from 2014 to 2018, before that he was to France in the period 2006-2012, during which he took part in the drafting of the Joint Declaration of the 2008 Paris Summit that marked the launch of the Union for the Mediterranean. Prior to that he held several position in Egypt and in various embassies, including Washington (1984-1988), Lisbon (1990-1994), Tunis (1994-1998), Brussels (1999-2001) and Paris (2001-2004).

Mr Kamel studied Political Science at Brussels University (1977-1979) and Cairo University's Faculty of Economics and Political Science, obtaining his bachelor's degree in 1981. He graduated from the Diplomatic Institute – Ministry of Foreign Affairs in Cairo (1981-1982) and the École Nationale d'Administration (ENA) in Paris (1982-1983).

He holds the title of *Grand Officier de l'Ordre National du Mérite* of the Republic of France and has also received decorations from the Kingdom of Belgium and the Republic of Portugal.

He is fluent in Arabic, English and French. He is married and has two children.



Mrs. Luisa M. García

Luisa García is a career diplomat. She graduated in Political Sciences and Administration, specializing in International Studies, at the University of Santiago de Compostela (Spain), and postgraduate in International Law and International Relations at the Complutense University of Madrid.

She entered the Spanish Diplomatic Career in 2005 and since then has held various positions in different Spanish diplomatic missions abroad, in countries such as the Democratic Republic of Congo, Paraguay, the United Kingdom and Lithuania. She has also worked in the Spanish Ministry of Foreign Affairs at the Ibero-American Directorate, in the departments of relations with Central America and the Caribbean, and with the Mercosur countries and Ibero-American regional organizations, respectively.

She previously worked with UNDP's Bureau of Development Policy and Regional Bureau of Arab States as the regional policy advisor, providing technical advice on governance programs of UNDP offices across the Arab region. In addition to being a policy practitioner,

El-Mikawy's academic background includes research development and management at the Center for Development Research at the University of Bonn, Germany, as well as teaching at UCLA, AUC, the Free University of Berlin and the University of Elangen. She has published two books on Egypt with AUC press and several articles and book chapters on governance and institutional reform in Egypt and the Arab region, including with Oxford and Cambridge University Press. 




Mr. Raed Safadi


